Outcomes of Meeting 84



Outcomes of meeting 84

The board of the Stormwater Management Authority met on 4 December 2023 in Adelaide.

Key outcomes of the meeting were:

- The board approved funding of up to \$135,000 to the District Council of Loxton Waikerie for the Loxton and Waikerie Stormwater Management Plans.
- The board approved funding of up to \$292,785 to the City of Prospect for the HEP channel upgrade project.
- The board approved a variation for the Yandra Terrace Outlet upgrade work being undertaken by the City of Victor Harbor.
- The board approved funding of up to \$1.225 million to the City of Charles Sturt for the detailed design and construction of the Gleneagles Reserve detention (stage 1).

Category C funding round now open



The Stormwater Management Authority is now calling for applications for funding for Category C (capital works) projects under the Stormwater Management Fund. Up to 50% of costs will be considered. Eligible projects include:

- Detailed design of civil works
- Construction of civil works
- Land acquisition

Projects should be consistent with approved Stormwater Management Plans. Projects not consistent with an approved stormwater management plan will only be considered if there are demonstrated exceptional circumstances.

Farewell and thanks to David Trebilcock





Other funding opportunities



Cooler, Greener Wilder Grants Program

Green Adelaide's Cooler, Greener, Wilder Grants Program is now open. The program provides support to Adelaide's metropolitan councils to undertake projects that deliver greening outcomes, incorporate water sensitive urban design or biodiversity sensitive urban design principles.

One million dollars is available for councils in the Green Adelaide region to cool or green urban settings at a site, street or precinct scale. Grants of between \$25,000 and \$200,000 are available to local councils, with the expectation that recipients match any funding granted with an equal co-contribution.

To be successful in gaining funding, consider incorporating on-ground works (including planning and design work that links directly to on-ground works) that achieve integrated urban greening, watersensitive urban design and biodiversity-sensitive urban design outcomes.

Applications close 23 February 2024.

Disaster Ready Fund

The Australian Government is providing up to one billion dollars over five years through the <u>Disaster</u> Ready Fund (DRF), from 1 July 2023. The investment will improve Australia's resilience and reduce risk to natural disasters, with funding matched by state, territory, local government and other applicants, where possible.

Round Two of the DRF will deliver up to \$200 million of Australian Government funding for disaster risk reduction and resilience initiatives.

Proposals for South Australian projects must be submitted to SAFECOM, South Australia's lead agency, between 9am (local time) Monday 22 January to 5pm (local time) Wednesday 20 March 2024.

Applications can include in-principle contributions such as an application to the Stormwater Management Fund. The program focusses on projects that treat risks as identified in risk management plans (this could include stormwater management plans). This could also include the development of stormwater management plans referencing the Authority's priorities for stormwater management planning https://www.sma.sa.gov.au/wp-content/uploads/Stormwater-Management-Planning-Priorities-2022.pdf

An expression of interest process for South Australian projects run by SAFECOM has now closed but applications will still be considered, and applicants are encouraged to engage early with SAFECOM in the development of applications. Urban Rivers and Catchments Program

The Australian Government's \$200 million Urban Rivers and Catchments Program is now open for applications, with the aim of restoring the health of urban waterways for native plants, animals, and local communities.

Projects funded will help conserve native plants and animals such as birds, platypus and native fish. They will also improve access to waterways which provide for health and social wellbeing.

The program will support projects that improve waterways in urban, outer-urban/peri-urban and regional centres areas by:

- restoring and/or improving river areas, stream banks or aquatic habitats
- improving water quality, water in the landscape, and waterway connectivity
- improving urban green and blue space, water quality, and community access to nature.

Round two of the program is now open and applications close on 13 February 2024.

\$109 million (from 2024-25) is available for project grants under the opportunity. It is expected this will fund around 100 projects that bring life back to our rivers, creeks, wetlands, and waterways in urban, outer urban and regional centres.

There are two grant opportunities:

- Stream one small to medium-sized project grants of between \$150,000 to \$2 million for community-led projects. A total of \$51 million is available under this stream.
- Stream two large scale project grants of between \$2 million to \$10 million for projects that include co-investment. A total of \$58 million is available under this stream.
