Key Items from Meeting 93

The Stormwater Management Authority Board met on the 27th October 2025 in Freeling. Our October meeting was hosted by Light Regional Council.

Key agenda items from the meeting included:

- Approval of the Gawler River Stormwater Management Plan
- T2D Stormwater considerations and interactions with Brown Hill Keswick Creek Stormwater Management Plan implementation
- A review of the Stormwater Management Fund Guide for Applicants

The Board was taken on a tour of the Freeling Wetlands and stormwater reuse system by Light Regional Council staff. The stormwater management and construction of the wetlands was identified as part of the Freeling Stormwater Management Plan. The Board was also provided with a presentation on the Roseworthy water scheme, a project to manage stormwater runoff from the

Roseworthy expansion and provide an alternative water source for urban and agricultural uses in the region.

The Authority would like to thank Light Regional Council for hosting Meeting 93 and providing such an informative site visit and presentation.

2026 Category C Grant Funding Round Webinar

To assist local government to prepare for the upcoming Category C (capital works relating to stormwater management) grant funding round which will open in early 2026, Authority staff will be hosting an online information session on 16th December 2025.

Under Category C of the Stormwater Management Fund, eligible projects may include detailed design of civil works, construction of civil works and land acquisition. There is \$2.7million available in this funding round.

The information session will provide information on:

- the Stormwater Management Fund and the upcoming Category C funding round
- eligible projects and assessment process
- the role of the Stormwater Management Authority and Board
